18 read the facts that you put in there. Is there anything you'd like
19 to add or that you would like me to be aware of?

20 **Good Client [2:48]:** No, it's pretty much in there, what the
21 [REDACTED] warned me off and how I've recorded it and stuff like
22 that, so.

1 **Judge Cardozo [2:56]:** The [REDACTED], excuse me, what?
2 **Good Client [2:57]:** What they've told me.
3 **Judge Cardozo [2:59]:** Okay.
4 **Good Client [3:00]:** And I've worked, I- do you know, um, North
5 Salt Lake has an open case still regarding it.
6 **Judge Cardozo [3:07]:** Okay.
7 **Good Client [3:07]:** The reports...

20 letter. Thank you for that. What would you like me to know?
21 **Miss Deputy [3:43]:** Actually, they couldn't find any evidence
22 of the allegations.
